**ESTABLISHING REGULAR MEETINGS OF THE LIBRARY BOARD OF TRUSTEES**

WHEREAS Illinois State Law, 5 ILCS 120/2.03 and 75 ILCS 16/30-50 require the Library Board of Trustees to pass an annual ordinance providing the schedule of regular Board meetings, listing the time and places of such meetings,

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Helen M. Plum Memorial Public Library District;

**Section 1.** Regular Board meeting dates for the calendar year 2026 are the third Tuesday of each month, at 7:00pm CST, at the Library, 411 S. Main St., Lombard, Illinois. Note that, for the regular Board meeting in March 2026, the regular Board meeting will be held on March 18, 2026. The change of the regular Board meeting in March 2026 is necessary due to the fact that the third Tuesday in March 2026 falls on March 17, 2026, which is the date of the General Primary Election.

**Section 2.** The Library District Secretary shall publicly post or keep available for inspection by any interested party in the main office of the Library District the schedule of regular meetings dates.

**Section 3.** The effective date of this ordinance is October 21, 2025.
